Fees

The yearly fee is as follows:

- \$35 for girls' volleyball and basketball
- \$25 for cross country, track, and potentially softball.
- there are no fees for children **only** in boys' volleyball or poms

AMOUNT DUE:

If your child participates in only cross country or track the fee is \$25 per child.

If your child participates in basketball or volleyball the fee is \$35 per each child that plays those sports.

*For example, if a child participates in track and cross country, the fee is only \$25. **BUT....***

If a child participates in cross country, basketball, and track the fee is \$35.

Any time volleyball or basketball is included the fee is \$35.
